### **Suggested Bequest Language**

A **bequest** is a gift of property (for example, cash, securities, artwork etc.) through a will to a particular beneficiary.

A **specific bequest** is where Casey House Foundation receives a specific piece or amount of property for example, a sum of money or other assets.

#### **Specific Bequest - Sample Wording**

"I direct my Estate Trustee(s) to transfer the sum of \$\_\_\_\_\_ or assets of equal value that I may own at the time of my death, to Casey House Foundation, to be used for the general purposes of Casey House Foundation at the discretion of the Casey House Foundation Board of Directors. I request that Casey House Foundation publicly recognize this as a gift on behalf of:

A **residual bequest** is where Casey House Foundation receives all or a fraction of whatever remains of your estate after all debts, taxes, administrative expenses and specific bequests have been paid or distributed.

#### **Residual Bequest - Sample Wording**

"I direct my Estate Trustee(s) to pay or transfer (all or \_\_\_\_ %) of the rest, residue and remainder of my estate to Casey House Foundation, to be used for the general purposes of Casey House Foundation at the discretion of the Casey House Foundation Board of Directors. I request that Casey

House Foundation publicly recognize this as a gift on behalf of:

A **contingent bequest** only takes effect if the primary intention cannot be met (for example, if the named beneficiary does not survive the donor).

#### **Contingent Bequest – Sample Wording**

"If (name/s of primary beneficiary/ies) do/does not survive me, or shall die as a result of common disaster or within ninety (90) days from the date of my death, or as a result of a common disaster, I direct my Estate Trustees to pay or transfer \$\_\_\_\_\_ or all or \_\_\_\_\_% of the residues of my estate) to Casey House Foundation, to be used for the general purposes of Casey House Foundation at the discretion of the Casey House Foundation Board of Directors. I request that Casey House Foundation publicly recognize this as a gift on behalf of:
